This Golden Retriever is guaranteed as follows:

_____ To be sound and guaranteed to not have any life threatening diseases or problems that would affect the quality of life for this dog. If given the proper care, socialization and correct feeding schedule this dog should be acceptable in health, temperament and structure.

_____ There are no guarantees with the purchase of this animal.

THE BUYER AGREES:

_____ That the seller, Pine Mountain Kennel / Golden will have first refusal to repurchase the animal at the same price and terms listed in this contract if it is sold.

_____ To notify Pine Mountain Kennel/Golden of any change of address.

_____ To pay any costs or all costs of recovering the dog/bitch if the buyer gives or sells the animal to anyone without first consulting the seller, Pine Mountain Kennel/Golden.

_____ Said dog/bitch shall not be allowed to run at large in the community where the buyer resides or in any other place that the above dog could be endangered. Proper fencing is required.

_____ Said dog/bitch shall be given adequate and proper housing/shade and shall not be chained or tied out in any manner. In no instance may this dog/bitch be expected to be strictly an outside dog.

_____ Adequate and proper veterinarian care along with a well balanced diet and fresh water shall be provided fro the entire life of the dog/bitch. This will include

monthly heartworm care, yearly shots, and flea control other than flea collars, dips or shampoos.

_____ To remain in touch with the seller throughout the life of the dog/bitch. This could be by e-mail, phone, or letters at least once a year. Seller has the right to come and see the animal with prior notice given to the buyer.

REGISTRATON PAPERS

_____ Are supplied with the contract and dog/bitch is co-owned by the seller.

_____ Are supplied after the dog/bitch has been spayed /neutered and proof of such sent to the breeder.

In addition to the contract, the breeder will provide the purchaser with the following:

1. A three generation pedigree
2. An inoculation and worming record
3. Written instructions on dog care and feeding.
4. Information about grooming, care, raising and training your Golden retriever and the assurance of availability to answer further questions.
